





### **Encounter Data Processing System General Updates**

- Due to feedback provided by MAOs and other entities, the file naming convention for MAO reports are being generated to indicate whether the file is in 'Test' or 'Production', and Institutional, Professional, or DME submissions. MAOs can expect to see these updates in file names over the upcoming weeks.
- DME Encounter Data test cases have been released and can be found on the CSSC website at <a href="https://www.csscoperations.com">www.csscoperations.com</a>. Testing will begin on Friday, June 15, 2012 for DME end-to-end certification.
- Reminder! When submitting default NPIs, MAOs and other entities should include a true and valid Employer Identification Number (EIN) if it is available. Do not use the default EIN unless it is not available.



### **MAO-002 Reports**

Edits causing recent 'Reject' lines with missing error codes and error messages in MAO-002 reports have been changed to an 'Informational' edit status disposition. For the following edits, MAOs and other entities may resubmit the affected ICNs after Friday, 6/15/2012.

- 02120 Beneficiary Gender Mismatch
- 98370 Anesthesia vs. Anesthesia Same Code
- 98375 Anesthesia vs. Anesthesia Different Code
- 03015 DOS Spans Procedure Code Effective/End Date
- 00070 Ambulance Carrier-Locality Not Found
- For Edit 20505 Accurate Ambulance HCPCS and Revenue Code Required, when Revenue Code 540 is
  present, submitters must use one HCPCS code <u>AND</u> one mileage HCPCS code for each ambulance service
  line submitted.
- Due to the results of recent system analysis, **Edits 01045 Referring/Ordering Provider Name Mismatch** and **01046 Performing Provider Name Mismatch** for Professional encounters will be turned off.
